9. Activities: The seminar, which extended over two days, focussed on media reporting in South Africa and countries of the Great Lakes region. Delegates were present from South Africa, Malawi, Zambia, Kenya, Uganda, Cameroon, Sierra Leone, Ghana and Nigeria, in addition to local participants.

Mr John Allen, former Press Officer for Archbishop Desmond Tutu and the South African Truth and Reconciliation Commission outlined the objectives, methods and outcomes of his and general media reporting in these two functions.

Two staffers from the Institute for Justice and Reconciliation made presentations on a Community Healing Project in South Africa, and the activities of the Institute's Africa programme.

In questions and subsequent reflection, which continued during the subsequent WACCAR Assembly, delegates sought to contextualise what they had learnt to their home contexts.

No Statement was issued and there are no plans or budget to publish material.

No equipment was purchased.

10. Was the project successful? (If possible, please give measurable indicators.)
Yes, The presentations were informative and relevant. Delegates participated fully in the plenary and group sessions.
During the past two months, delegates have been sharing information and experiences from their home contexts. This has resulted in increased Networking among WACCAR members, which has not been a recent feature.
